### **REGULATION ACCEPTANCE, DISCLAIMER, AUTHENTICITY GUARANTEE**

- (ii) that the Photo has been entirely and exclusively created by the Participant as the sole author;
- (iii) that the Participant has obtained from all the persons represented in the Photo and/or every holder of the rights concerning every element of the photo all the rights of economical use which are necessary to participate in the Contest and gives Connexia s.r.l. the rights as indicated in the following paragraph.

During all the Contest period, the participant gives Connexia the exclusive right to publish the Photo on Internet as well as in the press and/or any other appropriate instrument to advertise and promote the Contest, accepting the obligation to indemnify and hold Connexia s.r.l. and its assignees harmless from any damage and negative consequence which derives from any third party's claim regarding the rights the Participant gives in order to participate in the Contest.
